#### **Incentive Terms and Conditions**

Incentives of up to \$5,000 are available for the installation or upgrade of a billboard from a standard to a digital billboard that has electric service exclusively provided by and billed under an Entergy electric rate. Entergy is offering a limited number of incentives; availability is subject to overall participation levels. Entergy reserves the right to modify this incentive program at any time at its sole discretion.

#### DIGITAL BILLBOARD ELIGIBILITY RESTRICTIONS

- Only Entergy customers with accounts in good standing are eligible for this incentive.
- These incentives are available only for digital billboards that are a minimum of 150 square feet in size.
- All electricity for the billboard must be provided by Entergy. Billboards using solar energy or another form of self-power generation do not qualify for this incentive.
- This incentive applies to digital billboards that are put into operation on or after January 1, 2017.
- The digital billboard must replace a standard billboard or be a new installation of a digital billboard. Replacing a digital billboard with another digital billboard does not qualify.
- Billboard installation must comply with all city, county or state government, and property owner or business association codes and regulations. All necessary permits must be obtained.
- Incentive application and any supporting documentation must be submitted within 120 days of billboard activation.
- Failure to comply with any foregoing requirements could result in denial of incentives.

#### ENTERGY RESERVES THE RIGHT TO AUDIT YOUR INSTALLATION.

Entergy reserves the right to randomly select incentivized digital billboard installations for audit. You confirm that you are aware of this right, agree to such an audit and agree to grant Entergy access to the premise or property as needed, to the extent reasonably necessary, to conduct such an audit. If the field audit discovers that the installation does not comply with the incentive claim form, the incentive may be rescinded.
