## Incentive Terms and Conditions

This electric forklift incentive covers up to \$500 (per forklift) of the equipment cost for the installation of a new or used class 1 or class 2 forklift, or up to \$250 (per forklift) for a new or used class 3 forklift, purchased or leased, and used by a facility that has electric service billed under an Entergy electric rate. Entergy highly recommends that all associated battery chargers be installed by a licensed electrician in accordance with local municipal codes and permitting procedures. Entergy is offering a limited number of these incentives; availability is subject to overall participation levels. Entergy reserves the right to cancel or modify this incentive program at any time at its sole discretion.

#### **ELECTRIC FORKLIFT ELIGIBILITY**

- Only Entergy customers with accounts in good standing are eligible for this incentive.
- These incentives are available for class 1, 2 and 3 electric forklifts, as classified by the Occupational Safety and Health Administration.
- Electric forklifts must replace an internal combustion unit OR be a new addition OR be an expansion to an existing fleet (electric equipment replacing existing electric equipment does not qualify for this program).
- Leased electric forklifts are eligible for the full incentive.
- Documentation showing proof of purchase, serial numbers, and dates of payment for all forklifts claimed must accompany this • incentive application.
- Incentive application and supporting documentation must be submitted within 180 days of equipment delivery and/or invoice date.

Failure to comply with any foregoing requirements could result in denial of incentives.
